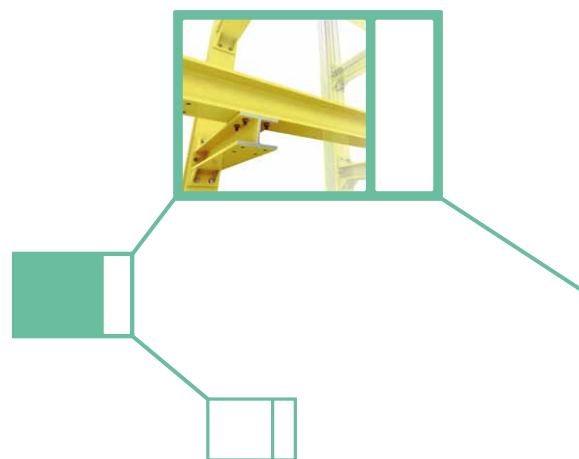


Minimising cost and risk in adjudication enforcement
