



## Corporate

## Our practice areas

The main practice groups within the Corporate Department are as follows:

- Corporate finance - advising private and public companies on fund raising including those listed on the London Stock Exchange or Alternative Investment Market. We are ranked top by The Legal 500, 2001 edition for our AIM practice
- Private equity - acting for companies raising first and subsequent rounds of finance and also for investment funds and institutions; including advising on management buy-outs and buy-ins
- Mergers and acquisitions - we advise on the sale and purchase of both private and public companies or their assets; a significant proportion of these transactions are cross border

- Partnership - we advise those collaborating through partnerships, including those raising funds through limited partnerships
- Competition, regulation and trade - we advise on both UK and EU competition, anti-dumping and merger controls with particular emphasis on Far Eastern and US based clients trading in Europe
- General commercial work - this work ranges from standard commercial contracts to complicated joint venture agreements, from directors' liabilities and responsibilities to corporate governance
- Corporate tax - our tax lawyers regularly advise on the corporate transactions described above
- Share options - we have a very wide experience in advising clients on establishing share option schemes, including what structures are typical within particular industries
- Financial services - we advise on all aspects of financial regulation
- Company secretarial - we have a dedicated group providing company secretarial services.

Alongside our legal practice areas we have developed expertise in a number of industry sectors including in particular:

- TMT - we are recognised as being leading advisers to those involved with the technology, media and telecommunications ("TMT") sectors where we work closely with our colleagues in the Intellectual Property Department, many of whom have worked in the relevant industry

- Healthcare - our clients range from multi-national pharmaceutical companies to those receiving their first round of funding; again we work with our colleagues in the Intellectual Property Department, many of whom have scientific backgrounds
- Advertising - focusing particularly on worldwide acquisitions
- Publishing - acting for both traditional and on-line publishers, again in conjunction with our Intellectual Property Department
- Insurance - advising on acquisitions, broking and regulatory work.

In addition we regularly assist our colleagues in the Finance and Projects, Commercial Property and Insolvency and Corporate Recovery Groups and frequently call on the services of our colleagues who advise on pensions and employment issues.
